What is RAMP?

Regional Alliance Marketplace for Procurement

- **RAMP** is a regional marketplace hosted by the City of Los Angeles and is designed to house in one place solicitation opportunities from public and private organizations.
- Most of the City's procurement spending is through the RAMP platform. RAMP is expected to hold **over \$10 Billion** in opportunities annually.
- RAMP is a valuable resource for vendors to learn about contract opportunities from numerous organizations in a single portal.

- Perform direct outreach to prospective subcontractors in accordance with Business Inclusion Program (BIP) requirements.

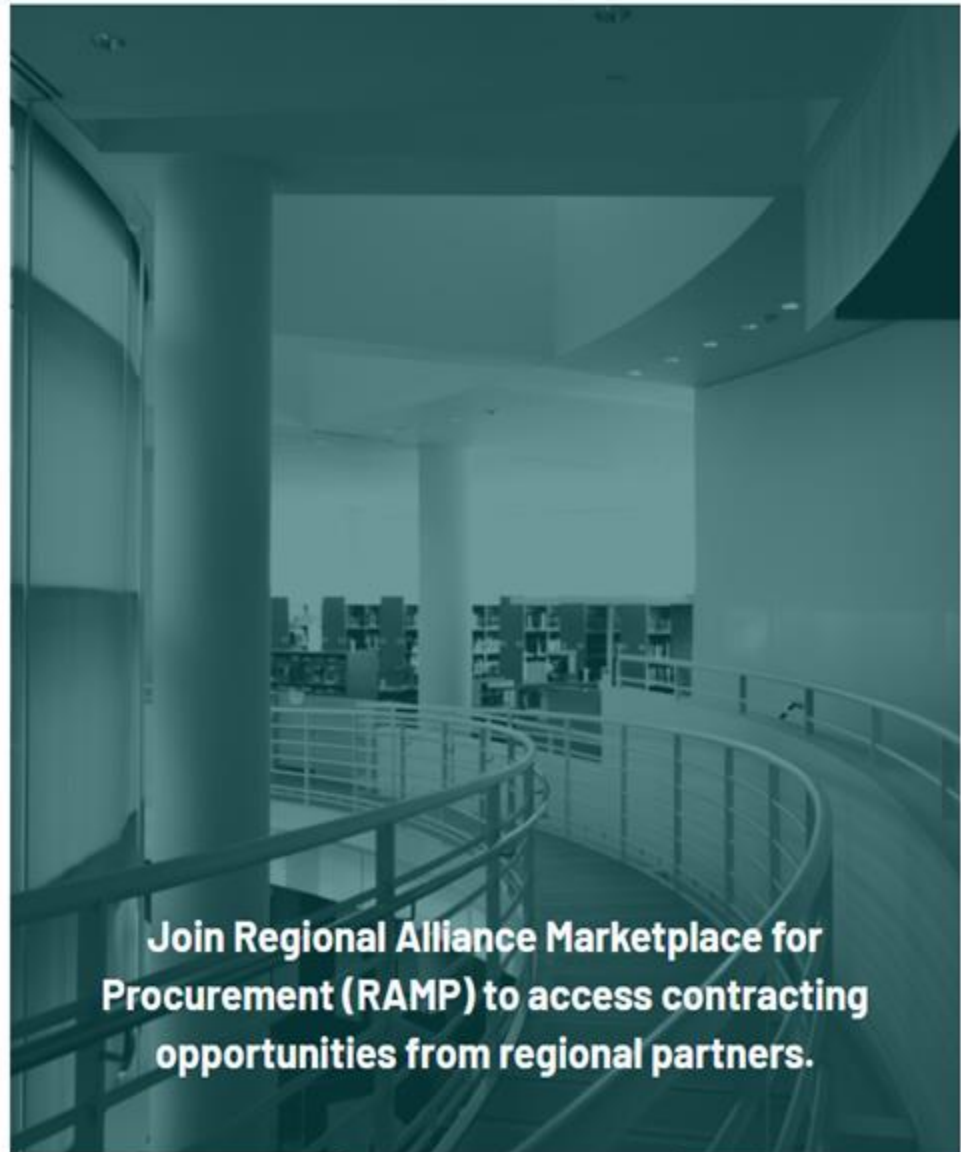

Where do I submit my compliance documents?


- All companies registered on RAMP may complete compliance documents in advance, or at the time of responding to a contracting opportunity.
- All forms may only be completed and submitted by the company Administrator on RAMP under the “Compliance Documents” section of your business profile, as shown on the next slide. Each form is only valid for a specified amount of time, as indicated.
- Please refer to the “Company Compliance Documents” manual under the RAMP Support section for detailed submission instructions.

Compliance Documents

The uploaded forms will be verified by the Bureau of Contract Administration (BCA) only if your company is the successful Proposer/Bidder selected for contract award.

Upon BCA verification, the Awarding Authority shall award the contract. If in the process of verifying the uploaded forms, BCA finds that the form(s) are incomplete, the awarding department shall be notified and your company will be required to re-upload the form(s).

Currently, all other forms pertaining to the Living Wage Ordinance and the Contractor Responsibility Ordinance shall be submitted with each bid/proposal.

Introduction to NAICS

The North American Industry Classification System (NAICS) is the standard used by Federal statistical agencies in classifying business establishments for the purpose of collecting, analyzing, and publishing statistical data related to the U.S. business economy.

NAICS was developed under the auspices of the Office of Management and Budget (OMB), and adopted in 1997 to replace the [Standard Industrial Classification \(SIC\) system](#). It was developed jointly by the [U.S. Economic Classification Policy Committee \(ECPC\)](#), [Statistics Canada](#), and Mexico's [Instituto Nacional de Estadística y Geografía](#), to allow for a high level of comparability in business statistics among the North American countries.

This official U.S. Government Web site provides the latest information on plans for NAICS revisions, as well as access to various NAICS reference files and tools. Additional information on the background and development of NAICS is available in the [History](#) section of this Web site.

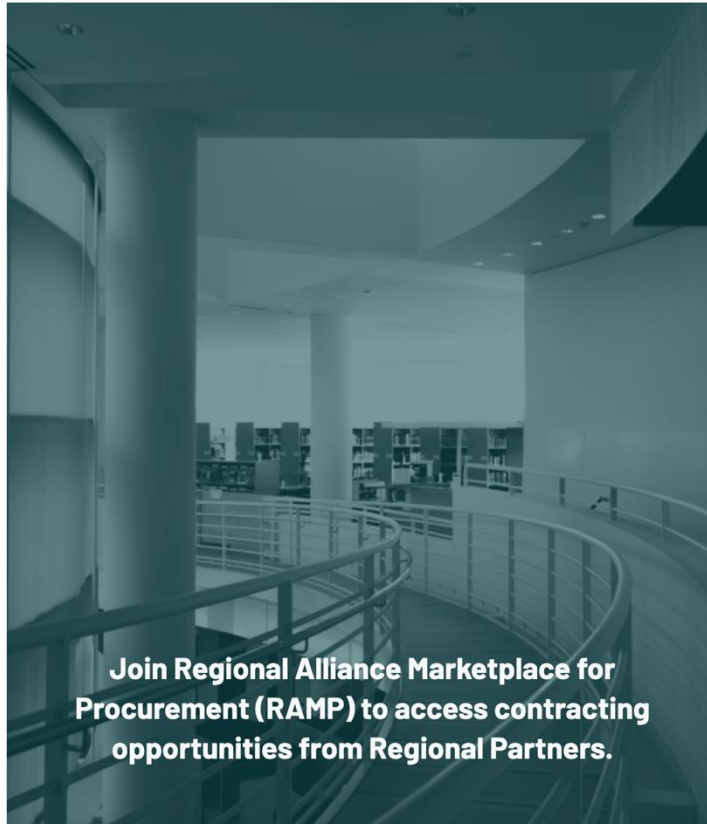
